## **News from Child Care Aware of WA Scholarships**

Child Care Aware of Washington Scholarships is excited to announce that we can now support home visitors, coaches and family support specialists with our scholarships. Starting this fall, early childhood educators working in the following roles are eligible to continue their education with our scholarship support:

- Lead &Assistant Teachers
- Early Achievers Coaches
- ECEAP Family Support Staff
- Directors

- Home Visitors
- Program Supervisors
- Infant/Toddler Mental Health Consultants
- Assistant Directors

Eligibility now includes early childhood educators who are working a minimum of 10 hours per

week at child care facilities participating in Early Achievers. Contact us to find out if you or your staff are eligible.

**Academic Advising Forms:** Scholars must submit an Academic Advising Form in the first calendar quarter of their scholarship contract.


Release Time Claim Forms: A benefit of your scholarship is the option to use Release Time if you and your employer agree to use it. CCA of WA Scholarships compensates your employer for claimed release time at a rate of \$11.00 per hour, up to 3 hours per week for time you take away from work for course-related activities.
