#### **Needs-Based Grants in 2020**

The Washington State Department of Children, Youth, and Families has opened Needs-Based Grants to Early Achievers providers rated 3, 3+, 4 and 5 through June 30, 2020. Providers that are participating in and rated Level 2 are also still able to apply. The maximum grant amount is \$1,000. #### **Substitutes for Early Learning Providers**

Eligible family home providers have access to five full days (10 hours per day) of paid substitute coverage July 1, 2019, to June 30, 2020, and five full days (10 hours per day) of paid substitute coverage July 1, 2020, to June 30, 2021.

As a licensed family home child care provider, you can use up to five full days of substitute coverage for the following:

- Early Achievers activities
- Personal illness or illness of a loved one
- Professional Development
- Holiday leave
- Personal time off

Arranging substitute coverage requires that you have a child on Working Connections, Seasonal or Child Welfare subsidy currently attending, complete a facility orientation and submit a Facility Agreement. Providers can email subpool@imaginewa.org for answers to questions.

### **Important Information About the 2020 Census**

One of the most under-counted populations in the U.S. Census is very young children. Did you know that federal money flows to states, counties and cities based upon population as counted in the census? That's why it is important to make sure all infants, toddlers and young children are counted so each region gets the funding it needs to help make sure that all of our country's children have what they need to grow and thrive.

# Provider Spotlight — Miranda Kirk, Rainbow School, Lakewood

For Miranda Kirk, opening her own home-based child care program is a dream come true. With a background in elementary school teaching and experience working at a child care center, she knew that for her "being around kids is the most joyful experience." She wants to maintain the strong relationships she builds with each child and family. With her own home-based program she gets to watch the children in her care grow for however long their families need child care.

In order to help make her home-based child care a reality, Miranda, who holds a BA in child development, took businesses classes, got licensed and then joined Early Achievers just weeks after opening. "I'm just really grateful there are some quality standards out there. They identify what is best practice for kids," she said.

One of the remarkable things about Rainbow School is that it is a vegan program. She and her life partner and teaching assistant Jacob Holloman provide breakfast, lunch and two snacks each day. The children in their care have "one-hundred percent freedom to choose what they eat," Miranda said. If a child doesn't like a certain food,



they find a substitute food that the child does like. Plus, each week they hold "Baking Fridays" where they cook and bake together and learn about food and measuring.

Rainbow School just opened this past September, so it is not yet rated in Early Achievers, though Miranda is looking forward to being rated. She describes herself as an advocate for children and believes that Early Achievers "is putting Washington at the forefront of what's best for children."

Did you know there are more than 30,000 children under age six experiencing homelessness in our state? Sadly, there are.

Attending high-quality child care has been shown to help reduce the traumatic impact that many children experiencing homelessness face. A steady routine in an enriching early learning environment, nutritious food, a loving early



educator and plenty of opportunities to play with peers all help to mitigate the effects of the family crisis. Plus, the adults in these families have time to stabilize their situations by attending appointments and other opportunities without having to worry about their children.

Our Family Center helps families with young children who are experiencing homelessness find child care at no cost for up to four months. Learn
